- 1. <u>Introduction</u>. The Kansas Health Foundation ("Sponsor") is offering the "#KHFGivingTuesday" sweepstakes (the "Sweepstakes").
- 2. <u>Eligibility</u>. THE SWEEPSTAKES IS ONLY OPEN TO LEGAL RESIDENTS OF THE UNITED STATES OVER 18 YEARS OF AGE ON THE DATE OF ENTRY WHO MEET THE OTHER QUALIFICATIONS OF THESE OFFICIAL RULES ("you" or "entrant"). The Sweepstakes is subject to all applicable federal, state, and local laws, and VOID WHERE PROHIBITED, including without limitation, any jurisdiction where registration of the Sweepstakes or other action, including making additional disclosures, is needed to comply with applicable law, including without limitation New York and Florida. Directors, officers and employees of Sponsor, its parent, the Sweepstakes judges, and any of their respective affiliate companies, subsidiaries, agents, professional advisors, advertising and promotional agencies, and immediate families of each are not eligible to win any prizes. - 4. <u>Sweepstakes Period</u>. The Sweepstakes will commence on 12:01 a.m. CST on Sunday, Nov. 26, 2017 (the "Start Date"), and will continue until 11:59 PM CST on Tuesday, Nov. 28, 2017. (the "Deadline"). The period of time from the Start Date to the Deadline is the Sweepstakes period ("Sweepstakes Period"). All entries must be received during the Sweepstakes Period to be eligible to win a prize.
- 5. <u>How to Enter</u>. During the Sweepstakes Period, you can enter the Sweepstakes in the following way: Anytime between Sunday, Nov. 26 and Tuesday, Nov. 28, if you contribute to a nonprofit organization in Kansas or one benefiting Kansans, post about it on Facebook, Twitter or Instagram, and use make sure and use #KHFGivingTuesday. If you don't use social media, but would still like to enter to win, you can send your information, via email, to cwillhite@khf.org and use the subject line #KHFGivingTuesday. For every post or email, the nonprofit organization mentioned will receive one (1) entry into the drawing.

In the event of a dispute as to the identity of a potential winner based on an email address, the potential winning entry will be declared made by the authorized account holder of the email address submitted at time of entry, provided such person meets the eligibility requirements of these Official Rules. "Authorized account holder" is defined as the natural person who is assigned to an email address by an Internet access provider, on-line service provider or other organization (e.g., business, educational, institution, etc.) that is responsible for assigning email addresses for the domain associated with the submitted email address.

If a winner drawn is a resident of a state or other jurisdiction where this Sweepstakes is prohibited or other registration or action is required, another entry will be drawn to determine the winner. To claim a prize, Potential Winners should follow the instructions contained in their notification. - 10. <u>Additional Conditions Use of Entrant Information</u>.
