

Privacy Policy

Overview

Kansas Health Foundation respects your privacy and is committed to protecting any personally identifiable information that you provide to us. Except as indicated below, Kansas Health Foundation will never sell, rent or share your personally-identifiable information without your consent. Collection of Non-Personally Identifiable Information

Kansas Health Foundation web servers automatically capture non-personally identifiable information including - but not limited to - domain name, IP address of the web page you used to enter the site, the pages you visit on the site, your click-through rates and the amount of time you spend on the site. However, you "the individual user" will remain anonymous. We may use and analyze the data captured to determine trends and improve the site. Any non-personally identifiable information that we share with third parties will be in aggregate form only.

Collection of Personally Identifiable Information

If you engage in advocacy activities on our site, you may be required to submit personal information such as your name, address, phone number, fax number and e-mail address. If you choose to withhold the requested information, you can continue to use the site but may be unable to access certain offers, services or secure pages. We will not provide any personally-identifiable information to third parties without your consent, unless we reasonably believe that the release of such information is necessary: 1. to comply with legal requirements or legal process; 2. to protect and defend the rights or property of Kansas Health Foundation; or 3. to protect the public or other users of the site.

Submitted Content

When you submit content to the site, your name (first name, last initial), city, state and comments/content are treated as public information; however, we will never publicly post or disclose your e-mail address, phone number or address without your consent. You understand and agree that we are not responsible for any information that you provide here, and you recognize that others may collect and use any information you provide.

Privacy with Respect to Minors

We do not knowingly collect or use information from children under the age of 13 without the consent of a parent or guardian.

Cookies

When you visit our website, we may place a cookie on your computer that will allow us to track your visit to our site and help us to improve the site. The cookies will not provide us with any personally-identifiable information about you.
